Our year started off with our Department Finance Committee making some difficult decisions about budgeting in an effort to ensure a balanced budget that our members can be proud of. Even after the close of the legislative session, this team continues to work hard to ensure that veterans issues are front and center with our elected officials.

I could go on and on about the dedicated volunteers who continue to work the programs of The American Legion, but I don't have enough space. I want to take a moment to thank all our posts for their dedication to the mission of The American Legion. Your dedication and hard work for veterans is unparalleled.

We still have some work to do in membership. We are still struggling with department atlarge renewals and overall new member recruiting. As anticipated, The American Legion Department of Minnesota had another busy year with some wins and some losses.

The big win is how The Minnesota Veterans Assistance Fund (MVAF) has taken off. To date we have assisted our Minnesota veterans with donations of over \$200,000. This program puts the true meaning into the last clause of our preamble, "To consecrate and sanctify our comradeship by our devotion to mutual helpfulness."

However, we have a few posts and members that are struggling with the concept of the last clause of the Preamble and have refused to assist a veteran in need. I won't call them out here, but they know who they are, and I pray they will see the light and be a part of the good of The American Legion.

The department has enrolled in a program called Unite Us to aid in not only managing the growing caseload but to refer our Minnesota veterans to agencies outside The American Legion for help and guidance. This tool can be used by the posts to help refer the veteran to other agencies for help. The MVAF is not a quick Band-Aid fix as it is evolving into a longterm program that will assist our veterans long term so they can enjoy life as they are so deserving.

The Department Legislative Committee worked their tails off this year to voice the department's praise and concerns on legislation our representatives debated this year.

We commend our state senators and representatives for passing the stand-alone omnibus bill for veterans again this year for the second year in a row. This sets a precedence. Another win is homeless veterans who seek shelter can keep 30 percent of their income versus less than 10 percent in past years.

Our biggest disappointment is the tax bill that hurts our posts with charitable gambling rolling back what and how e-pulltabs will look like in the future to what they were when no one played them. No one with any common sense would or should want to hurt our veterans or any of the many Minnesota charities. However, I guess that is what politicians want. One side voted for this bill, arm in arm, that hurts not only veterans in need but all charities in Minnesota.

Be assured our Department Legislative Committee is already strategizing for the 2024 session to overturn this disrespectful act by our state representatives. Remember 2024 is an election year and don't forget those who voted to hurt our veterans, our youth, our posts and our programs in The American

On a bright note, our younger veterans from Minnesota are beginning to step up and take on leadership roles in the department. I know in the 3rd and 4th districts officers are younger with energy and new ideas to hopefully stop the slide in membership, we have been in for the past 20-plus years. For our old-timers — of which I am fast becoming one — don't be afraid to turn over the reins. Remember at one point in our Legion career an old-timer had faith in

I have greatly enjoyed the last year with all the activities that are associated with this very important position. This, along with being post and district adjutant, has kept me busy three to five days a week.

The year started with the national membership workshop in Indianapolis in late July. This was a great way to get to know the Minnesota membership team. It was very informative, a great way to network and to hear success and failure stories firsthand.

It was an honor to represent Department Commander Jennifer Havlick at a strong handful of events that she could not make in the 4th, 5th, 8th and 10th districts. Events included dinners, open house, testimonial, parade and Memorial Day speaker.

We, as an organization, need to find multiple avenues to increase member to just maintain our numbers, let alone grow. New members and post officers are out there. We all need to work at telling our story of why we belong.

I helped work a revitalization for the Edina post, which was held at community center, and ney there to assist over a dozen veterans that stopped by. We got two members to transfer into the post and they want to get active. Now, we have to go door knocking to get more members and eligible non-members involved this summer. The city was very supportive.

Assisting posts to improve or streamline activities is the best way to pass along my knowledge. Many were fairly simple tasks like online renewals, MyLegion access, member information, continuous years, ways to get new members. A handful were assisting posts that have strayed too far and need assistance to righten their ship back onto the Legion path. A couple are long-term projects.

It has been an honor to be one of your department vice commanders this past year. Thank you. I plan to continue serving the Department of Minnesota, the 10th District and Fridley Post 303 for the near future and for years to come.

When I last checked, there were still some openings available for this year's sessions. I am saddened to see Gene Leifeld leave the board this year. Gene spent many years on the Legionville board. His activity over the years is without equal. I am happy to report the board awarded him member emeritus status. He will be missed.

The latest preliminary data from the Department of Public Safety's State Fire Marshal Division reports that 70 people died in fires in Minnesota last year. This is the highest number of death due to fire since 1995. The leading cause of fire deaths in each of these years was careless smoking. The bulk of the deaths were in people 50 and over. A non-working smoke detector was found in about a third of the fires that resulted in death. The numbers will be confirmed later in 2023, after hospitals in the state report the last of their areas. Let's all think safety. data to the Minnesota Department of Health.

Authorities are reminding Minnesotans to not leave their space heaters, candles or food cooking on the stovetop unattended. There are many little things we can do to prevent a devastating fire from happening in our homes. It is important to practice fire prevention and safety every day. Officials recommend that homeowners test their smoke and carbon monoxide alarms monthly, and also create a family escape plan in the event of an emergency. Sprinkler systems have been proven to save lives and reduce the dollar loses.

Last year had a reduction

The five Minnesota Amer- in traffic deaths compared to the previous year. Preliminary numbers show 444 people died, down from 488 killed in traffic crashes in 2021, compared with 394 last year and 364 in 2019.

Of the 444 fatalities 22 people died in distracted driving-related crashes, 128 people died in speed-related crashes, 141 people died in alcohol-related crashes, 89 people died who were unbelted, 45 were pedestrians, six were bicyclists, 80 were motorcyclists.

Alcohol was a major cause of crashes on our roadways this past year. The Minnesota State Patrol has been joined by other agencies concentrating on speed enforcement with saturation patrols. Increased presence during high travel times has helped to reduce crashes. There were 25,872 reported arrests for impaired driving last year. Drinking and getting behind the wheel is also a bad idea. Use of drugs is also not to be done when operating a motor vehicle.

The highest number of arrests were made during the month of May. Public safety organizations increase patrols during this period. Motorcyclist deaths also increased this past year. I encourage bikers to make themselves visible. Dark clothing on a dark road doesn't help you to

I encourage everyone to watch for pedestrians, bicyclists, motorcycles and, yes, farm equipment.

I remind everyone, too, of the need for safety on the water and on recreational vehicles. There were 22 deaths resulting from ATV/OHV operation last year. The Minnesota Department of Natural Resources reports 15 boating fatalities and 30 non-boating drownings. We are known for our outdoors activities. I encourage everyone to think safety first. Nothing takes the joy out an activity as much as would an injury or death at an activity designed to be enjoyable.

Safety is not just for our youth. I encourage posts to invite your district Minnesota State Patrol safety officer to a general membership meeting to present a program on this and other issues. Fire, police and other safety program professionals are available most times just for the asking. I encourage you to use them.

Every community has its own safety concerns. I encourage Legionnaires to identify these areas of concern and implement programs of safety education. I am aware of many posts that are hosting safety programs and networking with other groups to provide safety training in many

#### **Armed Forces Service Center**

The Armed Forces Service Center (AFSC) at the Minneapolis/St. Paul International Airport (MSP) is open seven days a week. Current hours are 0800-

These hours will be extended Division II Juniors. The second when there are more trained volunteers to staff the center. The goal is 24 x 7 x 365 — as it was for nearly 50 years.

The AFSC is located inside security on Level 2 at the entrance to the A Concourse and is open for traveling active-duty military (including National Guard/Reserve traveling on orders), their dependents, former POWs, Purple Heart Recipients, and Medal of Honor Recipients. Retirees and their dependents are welcome on a space-available basis. Due to current COVID and DoD travel restrictions, they currently offer grab-and-go lobby seating for recruits, DoD civilians, and PHS personnel. An update will be posted as soon as the restrictions are lifted.

The AFSC is a one-of-a-kind facility, supported by a volunteer workforce and contributions (financial and in-kind product donations) received from various veterans' organizations, corporate and personal contributors. It is not affiliated with the USO, and does not receive funds from the US Government. It is a 501(C)(3) organization, so Post gambling funds may be used for donations. Individual donations are also encouraged. Donate now via GiveMN. org (https://www.givemn.org/ donate/Armed-Forces-Service-Center-1).

Volunteers at the Armed Forces Service Center (AFSC) set their schedules via an online scheduling system. They are asked to work two four-hour shifts per month for a minimum of one year.

Volunteers must be at least 21 years old. A 10-year background check will be conducted on all volunteers prior to an airport badge being issued.

The AFSC relies on their volunteer workforce to provide a hospitable environment to maintain a top-rated Military Center. Duties include meeting and greeting guests, checking eligibility identification, limited food preparation, offering Center amenities, and light housekeeping tasks. ## Legionville

At the fall meeting of the Legionville Board of Directors, held in September 2022, I was elected president. I want to thank Eugene Leifeld for his years of service to Legionville as our previous president. His leadership and dedication to Legionville is greatly appreciated.

The Legionville Board of Directors met on March 2023. All districts were represented.

Guest speakers were Department Service Officer Ray Kane, who proposed using Legionville to provide retreats for female veterans once a year. This would be conducted over a weekend to discuss how healthcare could be improved for the female veteran.

Another speaker was Kurt Roettjers from the Shine Cody Shine Foundation, whose mission would be for veterans and first responders experiencing PTSD. He was interested in using Legionville a few times a year to provide an environment where veterans would feel safe, open up and share their experiences.

Department Judge Advocate Greg Colby raised concerns that the Legionville Constitution and By-Laws, and Articles of Incorporation, do not provide for year-round use or other programs that deviate from the teaching of safety patrol, Americanism and citizenship.

A motion was made to have the board secretary, department judge advocate and me look into the expansion of the current Articles of Incorporation to expand the use of Legionville.

The camp manager, Adam Felton, provided a report from AAA with concerns that some schools are using Legionville graduates to teach other kids within their schools. We were reminded that the only certification is the training received from AAA and Legionville.

homeless shelter to identify and approximately 80 acres of land were previously put on sale. They have been taken off the market due to declining land values.

#### Rehabilitation

Fellow Legionnaires,

It has been a productive year for the Veterans Affairs & Rehabilitation Committee; many changes have been made to our program. The goal was to offer more transparency for any American Legion member by making sure that every member could view and request financial information and meeting minutes. Another aspect we hope to see more participation in is that meetings are open, and any

and speak. We rely on all of you to let us know what is happening in your area because we want to find a solution. When I say transparency, there will still be aspects of VA&R that will not be shared due to privacy. However, the goal is for members to have a greater understanding and ability to be involved with VA&R.

We hired a department service officer and an assistant department service officer, dramatically impacting how we move forward with our goals. Ray Kane hit the ground hard and immediately established a strong program. Ray brought a new element to the position that we had never considered: partnership; he used his relationships to strengthen our already robust program. Then Janet Lorenzo joined the team, added some polish to the program, and identified areas for improvement. Janet comes with a background in social work. She does a great job working in partnership with other programs to ensure all our veteran's needs are being met. These individuals have a passion for helping veterans and supporting families, which shows in everything they do. To Janet and Ray, this is more than a job; this is a passion and a lifestyle for these individuals.

At the beginning of the year, we had a massive shift in leadership, which allowed us to build a program that would serve Minnesota veterans for many years. One of the most significant changes that came to light was compliance issues. We did not comply with Minnesota wage and employment laws, which were corrected with a simple hiring contract. The other missing aspect, which is no one's fault, was that we did not comply with National American Legion service officer expectations. Past staff member Sarah Sturner and I created a new job description that envelops the needs of Minnesota veterans and nationals' overall goals. This job description allows every Legion member to understand what our DSOs priorities are, and this allows for performance accountability to be tangible.

#### **VA Medical Center**

We have always had and will continue to have a strong relationship with the MDVA. We are a partnership with them and are not there to cause friction. We are the ears to assist veterans with their concerns and help develop solutions. Sometimes, solutions are only sometimes; Chairman please keep in mind that Ray and Janet are not miracle workers; they cannot change hospital VA Medical Center Minneapolis; the goal is to ensure our team is accessible and that the American Legion has a presence in all VA facilities.

Minnesota has a massive network of CVSOs, and they are considered the experts in the claim process. With this aspect, claims work will be a minor priority because the CVSOs have around 185 members. Where we come in is veterans admitted for long-term care, it is difficult for CVSOs to get to the hospitals to assist in these cases. Another aspect we identified is that CVSOs struggle with primary complaints about the

presence where we can use our relationships to support those counties. Things like billing have continued to be an issue, and it has been for over 20 years. However, we can help veterans understand the debt, set up a payment plan, or ask for leniency.

We are still actively working on a way to support the many volunteers at the VA. We will continue working with that team to ensure those needs are met. There hasn't been a lot of us to do as far as the volunteers.

One aspect we are excited to announce is the Nurse of the Year award. Nurses are often overlooked, and Jan Eckert had some great insight on how we can make the award a reality. Nurses often work long hours and have the most time for the patients. A nurse can change a veteran's experience, and nursing is truly a labor of love; in August, a description will go out to the district VA&R reps, and we will rely on them to make this program successful.

#### **Claims Work**

We have a relationship with MDVA, where they process all our claims, saving us substantial money. Eight MDVA employees are to work specifically on claims and are considered experts. We have a team with a diverse background, and the majority have over 10 years of experience. Since we do not process our claims, the Whipple Building office was not needed. We would utilize such a space to put our claims workers and VSR (veteran service representatives) in the exact location. We turned in the keys for that office and moved our staff to the department offices, allowing the DSO

to be accessible. One struggle during this transition was accreditation with The American Legion. The staff transition created some confusion and caused a more efficient process to be developed between our DSO and National HQ. We will continue to adjust as necessary to ensure we do our best to get accreditation approved promptly.

#### **Veteran Advocacy**

We have always had a substantial role in making changes that benefited our veterans. While we have always been able to enact change, it is essential to remember that there is always room for more. Ray and Janet started attending outreach events and building connections with state and national lawmakers. We utilized our relationship with Hastings Veterans Home. The American Legion is now in the veteran community; we have policy. We moved the primary new contacts and even more office location of the DSOs to resources to serve our veterans

Veteran homelessness has become a significant issue, and we have identified many areas that need to be filled in. MACV is not an easy agency to work with, but we intend to continue to bridge that gap and support them. We have done our best to create a network of connections to put a roof over a veteran head and help them succeed going forward. The lack of a place to live is only a tiny piece of the puzzle; we need to ensure Concluding thoughts that we are working on ending homelessness and assisting veterans to attain sustainability.

member is welcome to attend hospitals; we have a physical changes veterans' lives. We are not here to pay veterans' bills to help them in the short term; we are ensuring this helps a veteran forever. We are stewards of this fund, and we are responsible for using those funds responsibly. If you can help us maintain Fund 85, we rely on you to keep us moving forward. One of my goals is to throw a significant fundraiser event that VA&R will take the lead, but I am not sure what year I will get that goal executed.

> We have started working with the Department Legislative Committee supporting their efforts. In return, they are supporting ours. We have many opportunities to speak at outreach events; we need to ensure we support the overall message of The American Legion. As different as Legislation and VA&R are, there is much overlap, and we must work together as a team. Kristy Jaingo has done a great job supporting our mission, and we are always there to support the legislative committee's mission. When we work together, veterans win, which is what we are here for.

#### American Legion Responsibilities

We work for the membership of the American Legion. Our DSOs are still required to attend department meetings and events. I have challenged that further and would like to include our DSOs in at least one district event for all ten districts. Our goal is to make sure the DSOs are accessible to everyone, and every district should feel that they can connect with the department committee no matter what. With Committee members assigned to two districts, every effort should be made to attend those district events.

Post service officers are vital to our success. We need to find out what resources are available in every community, and we rely on you. Post service officers, there is a training, and you are welcome to call a DSO or a committee member at any time if you require additional training. Post service officer should be something other than a role you take to have an office; service officers build a network of resources. The post-service officer should be doing the investigation piece of the MVAF application. Often there is a resource that can help a veteran in a community, and we don't need to use the grant.

When we attend outreach events, the DSOs represent the American Legion. They wear Legion attire, include their cover, and conduct themselves professionally. We are an organization that is accepting of all veterans, and we continue convey this model. The DSOs can sign up members at events or get contact information from the appropriate districts. Membership is everyone's responsibility. When we become a more robust presence, membership will come; one of the biggest hurdles is that many veterans feel the American Legion is nothing but a bar; we are much more than a bar; we are the most extraordinary veteran organization.

This program will always be ever-changing to ensure that we are meeting the needs of vet-Our MVAF is a program that erans. The VA&R committee

and the department service officers are responsible for staying informed on veteran issues. While we had a strong program before, we now have one that will propel us forward to being the most extraordinary veteran organization.

For the remainder of this report, the DSOs will give you a breakdown of site visits. These site visits will continue to be the backbone of the committee. An in-person visit lets us see, talk and experience these facilities. Each site has different strengths and weaknesses and ways The American Legion will support these facilities. I have asked for the remainder of the report to be an overview of each site and explain our concerns and goals for the next year per site.

#### Rehabilitation DSO & ADSO

We are pleased to present the annual report for the Department of Minnesota Veterans Affairs and Rehabilitation Committee. highlighting our significant achievements and efforts toward supporting and rehabilitating veterans. Throughout the year, we have engaged in various activities and collaborations aimed at improving the lives of our honored veterans.

Our commitment to serving veterans has taken us to several communities, including Hastings, Minneapolis, Laverne, Silver Bay, Fergus Falls, Fort Snelling and Sioux Falls. During these site visits, we assessed the needs of local communities and identified gaps in services, allowing us to develop targeted solutions.

In terms of healthcare, we made, three visits to St. Cloud VA Medical Center, Minneapolis VA Medical Center and collaborated with the Anoka Veteran Center, emphasizing the importance of comprehensive and accessible medical care for our veterans. We had the privilege of meeting VA Secretary Denis McDonough and Minnesota Deputy Commissioner of VA Healthcare Eric Meittunen, discussing ways to enhance support services to ensure continuity of care.

Our collaboration with Sen. Erin Murphy and Commissioner Larry Herke demonstrates our commitment to advocating for veterans' rights. Working alongside government officials allows us to address policy gaps and ensure that veterans receive the support they earned and deserve.

The improvement of the Hastings VA home has been a priority. We worked closely with MDVA staff to implement necessary updates, enhancing the quality of life for veterans residing in the home. Attending the signing of the Veterans & Military Omnibus Bill was a significant milestone, reinforcing our dedication to legislative efforts and care of Minnesota heroes.

We actively participated in Legion events throughout the year, including flag retirement ceremonies, district and department rallies, and the celebration of the 25-year anniversary of Fergus Falls. These events provided us with opportunities

to connect with veterans and recognize their contributions.

In our pursuit of holistic care, we collaborated with volunteer services to bring a coffee cart and entertainment to the flag atrium area, fostering a supportive and engaging environment for veterans. Attending Spam and venison events at the Minneapolis VA Home further strengthened our connections within the veteran community.

Education and empowerment have been key focus areas. Ray taught at Legion College and Janet speaking engagement at a Women's Veterans Day event hosted at Apple Valley Post 1776 allowed us to share knowledge and provide support to veterans; we have been invited for future events and have been considered a one-stop shop for resources and advocacy. We are proud to serve as mentors for veterans court for Ramsey and Dakota counties, ensuring that veterans receive guidance and assistance throughout their rehabilitation journey greatly considering The American Legion was able to get the Veterans Restorative Justice Act passed through the Legislature back in 2021.

We wrote a resolution for Chapter 33 to ensure the VA is following the industry standard after the pandemic, as colleges are moving towards online classes, this ensures our nations heroes are able to fully maximize their education benefits that was earned during time of service. This is an important resolution for the reason that it allows the veterans or servicemembers to receive a housing allowance to lessen the financial burden as they focus on their

Expanding our reach and influence, we have been working closely with National VA&R Director Tiffany Ellett to pilot Unite Us in five additional states. This initiative aims to improve access to essential services for veterans, facilitating their rehabilitation process. We have taken on 92-plus cases, 80 percent of those being a fourday-or-less turnaround, 70 percent less than a two-day turnaround, 63 for income support, 10 for veterans' homelessness of urgency, 22 referral cases to other organization for additional services, 6 cases for adaptable equipment for mobilization of

We prioritize the well-being of veterans within healthcare facilities, and as part of our efforts, we followed up with the Minneapolis VAMC through the patient advocate, ensuring that veterans receive the best possible care and support.

Preventing homelessness is a critical aspect of our work. By assisting 10 veterans in avoiding homelessness, we have made a tangible impact on their lives. To continue this vital work, we advocate for additional funds to be donated to Fund 85, enabling us to support even more veterans in need.

In collaboration with MDVA and DAV, we have utilized the Hospitalization Fund to provide assistance to members who have been a part of the American Legion Family for over three years. This collaboration strengthens our collective support network.

As we reflect on the past year's accomplishments, we are grateful for the dedication and support of our committee members. Together, we have made a significant difference in the lives of veterans, and we remain committed to our mission of ensuring their successful rehabilitation.
